Julissa:

Just got back from meetings with President Preval, First Lady Elizabeth Preval and Prime Minister Jean Max Bellerive. In addition to being thanked by them for our assistance and my conveying Gov. Fortuño's offer to continue assisting Haiti through USAID, SouthCom and NGO's such as the Red Cross, they emphasized that all assistance should be "coordinated", which I assured them is being done.

They were particularly grateful that our public utility, PREPA, arrives tomorrow in PaP to begin an assessment of the power situation and will join a consortium of Dominican and US power companies that will help restore service. We all agreed that a functioning electric service would bring stability to the city and to the nation.

I reiterated the offer from Gov. Fortuño I'd conveyed in December to the PM in Miami that we'd be available to assist in Haiti's long-term development, especially higher-ed.

We've postponed the departure of a 6,000-ton barge for late tomorrow or Friday, in order to accommodate additional cargo (thousands of tons), to be delivered to a private port in PaP. We need USAID's confirmation that they or a responsible NGO will receive and handle distribution of the goods.

USAID's response and coordination would be appreciated.
