I would say that: There appears to be misinformation circulating. While sympathetic to all parties, the GOE has not indicated any willingness to interfere in the proceedings of the Egyptian courts that currently are considering Mr. Bower's challenge to the Egyptian custody decree. We do not know when that judicial process will be completed, although the next hearing is scheduled for October. The Embassy is currently trying to assure that Mr. Bower, who is en route to Egypt now, will be able to see his sons as called for in a current Egyptian court order.

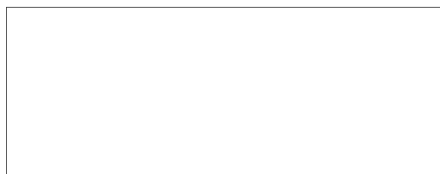
