Open session. They aim to ask SG to send an envoy (likely USG Lynn Pascoe) to 6PT countries and DPRK to try to ease tensions.

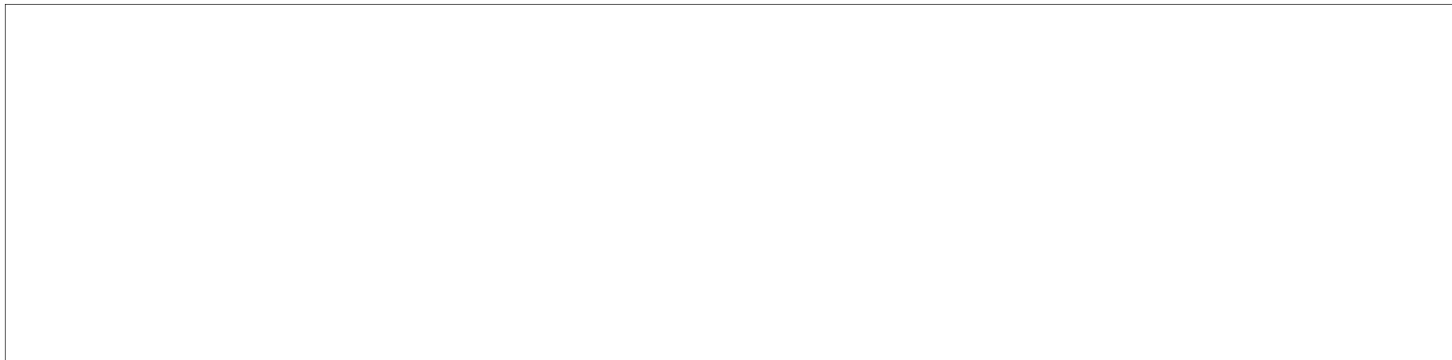
