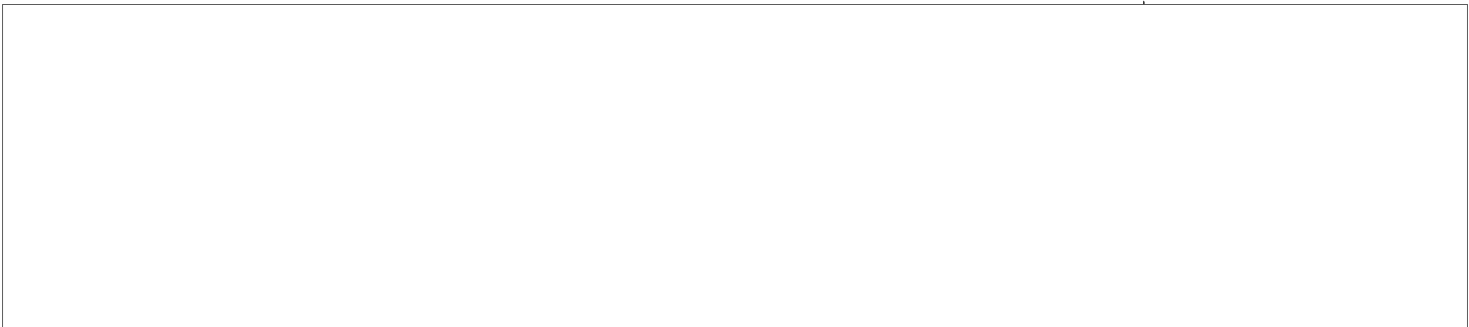
Thanks Phil. Only couple points to add:

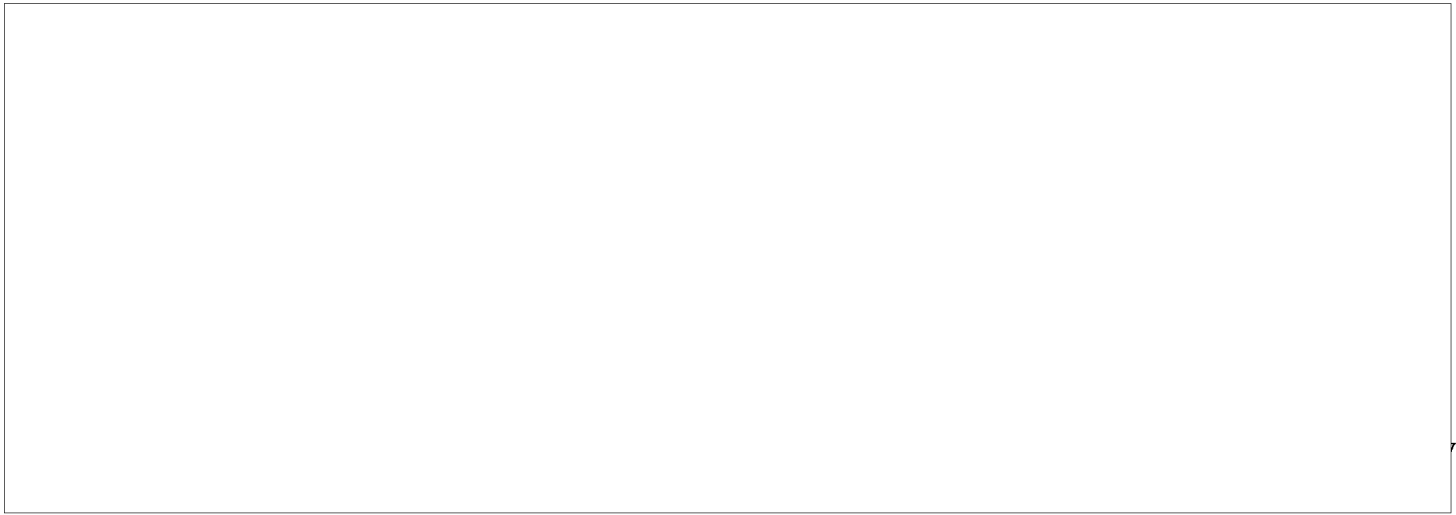
