I got through to my Norwegian counterpart here [redacted], and she told me that the Norwegian Foreign Ministry is working on the text of a statement that Oslo hopes to issue today. She was very worried that Norway had somehow end up catalyzing unjustified attacks on [redacted] and thought it important that Oslo set the record straight. She believed the statement would be short and concise. She encouraged us to raise the issue also in Oslo. The phone connection was a little shaky, but I think she mentioned that her Minister would be in Washington over the next couple of days.
