Arab League decided it prefers to start with unga track but may also go to unsc later, tbd. This issue will be part of negotiation with EU. (That is, they are using this tactic to amp their negotiating leverage with the EU). The Pals have begun engaging Ashton/EU on a "modular" UNGA text. The negotiation now is between the Pals/Arabs and EU. Re: timing of action at the UN, no formal discussion in Cairo but Pals heard strong message from US and Euros to wait until after high level week. No indication whether they will.
