On a tip from [redacted] who informed me minutes ago that Dorsinvil and thee other CEP members handed his [redacted] a document containing the confirmation of the BCEN's rulings, rejecting thus the JEOM's recommendations, to be handed to presidential aide Enech Jean-Charles for publication in Le Moniteur.

I called [redacted] who confirmed the information. He acknowledged the quandary, expressed fear for his safety should he not comply. He recognized that the JEOM's conclusions were correct, but felt powerless not to proceed as directed by Dorsinvil. I asked him to call SRSB Mulet, but he did not have the phone number.
