I also alerted the SFRC Majority and Minority Counsels of the situation in order that they have awareness of the situation. A short while ago I received a follow up call from Senator Lugar's Chief Counsel. He

explained to me that he has learned that Senator Rubio has been talking to other Republican members of the Committee to encourage them to join him in opposing Farrar's nomination. We obviously don't know what will come of Rubio's efforts, but because it may influence Farrar's decision on how to proceed, we let him know that there could be additional "no" votes in addition to Menendez and Rubio.
