Secretary LaHood may be calling [redacted] about his son, Sam, who was prohibited from leaving on his flight tonight. Apparently, he is on the exit control list, and there may be others. We got hints earlier in the day that there might be restrictions on departing the country and had talked to the Foreign Ministry about it.
