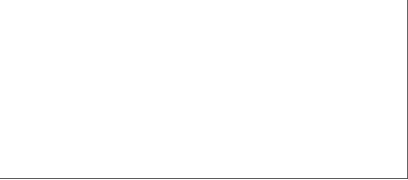

Per our conversation, I am writing to see if Mr. Nathanson would be interested in serving as one of Secretary Clinton's appointees to the Board of Directors for the East-West Center.

The East-West Center, based in Honolulu, promotes better relations and understanding among the people and nations of the U.S., Asia, and the Pacific through cooperative study, research, and dialogue. The 18 member board includes five members appointed by the Secretary of State, five appointed by the Governor of Hawaii, three ex-officio members, and five international members chosen by the Board itself. The Secretary's appointees serve for a three year term.

The Board meets twice per year in Honolulu, with several subcommittees on various initiatives.
