surveillance and financial tracking programs). Before his tenure as special counsel to President Clinton, Davis was a commercial, antitrust, government contracts, and False Claims Act litigator.

"I am pleased to bring my experience in strategic crisis management acting as an attorney, with attorney-client privilege, to Dilworth," said Davis. "I hope to assist Dilworth, using my experience on combining law, media, and politics, to solve client problems." Davis has participated in national, state and local politics for almost 30 years. He served three terms (1980 to 1992) on the Democratic National Committee representing the state of Maryland.

Davis graduated from Yale Law School, where he won the prestigious Thurman Arnold Moot Court prize and served on the Yale Law Journal; and is also a graduate of Yale University, where he served as chairman of the Yale Daily News. Davis is admitted to practice in the District of Columbia and Connecticut, before the Supreme Court of the United States, and the U.S. Court of Appeals for the District of Columbia Circuit.
