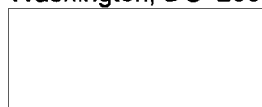
Dear Cheryl and Huma:

Dear Mr. Ambassador/Dear Sam,

I hope you and Sylvia are well. I enjoyed being with you at the NAPEO conference in Marrakech in January, and more recently being together at CSIS with the Moroccan Foreign Minister.

I am writing about a very exciting project, which can be very beneficial to Morocco and to U.S.-Morocco relations. I have absolutely no legal or commercial interests in this, but I have such a high degree of confidence in this project, I wanted to ask if you could help with it.

My friend Lucy Jarvis of New York City, at 95 years of age, is a living legend in the media business. She was an early pioneer for women in the industry. She has won numerous Emmy awards for her documentaries on subjects as wide-ranging as the Louvre Museum (she is the only person to have ever been permitted to film the Louvre), the Kremlin (with President Kennedy's intervention, she became the first person to film the inside of the Kremlin), and the Forbidden City in Beijing (again as a path breaker). She has been the most prestigious personal awards the television and film industry can offer.

Lucy wants to do a documentary on Morocco. The theme I suggested when we met last week in New York is Morocco as a model for the Arab world, following the Arab Spring.

I understand you and Sylvia are attending a dinner in her honor on May 22. But I hope you might take time to meet with Lucy and her talented associate Scott McArthur, with whom I also met, and to help her think through the best way to approach this documentary. I am sure it will time well spent for you and Sylvia, for your Embassy, and for U.S.-Morocco relations.

I am attaching her itinerary, and biography.
