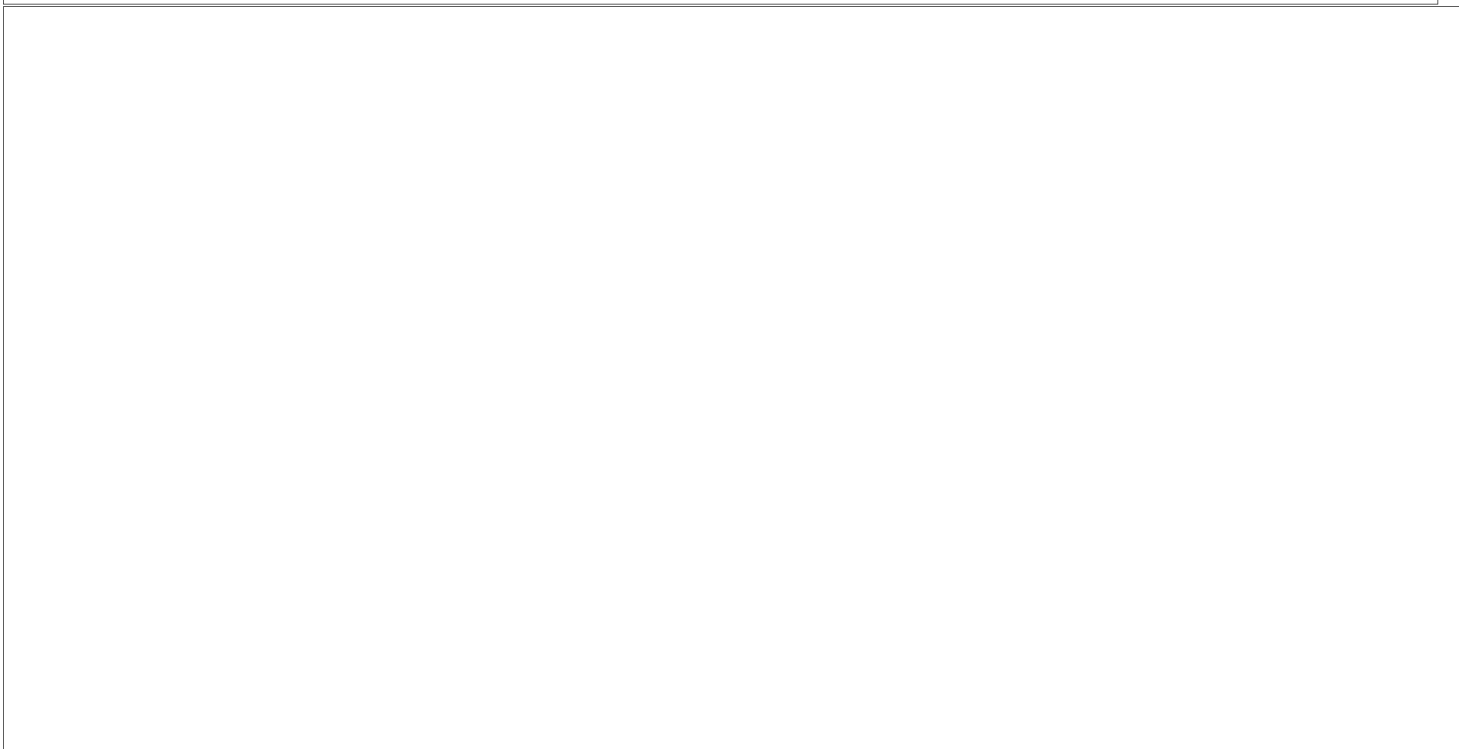
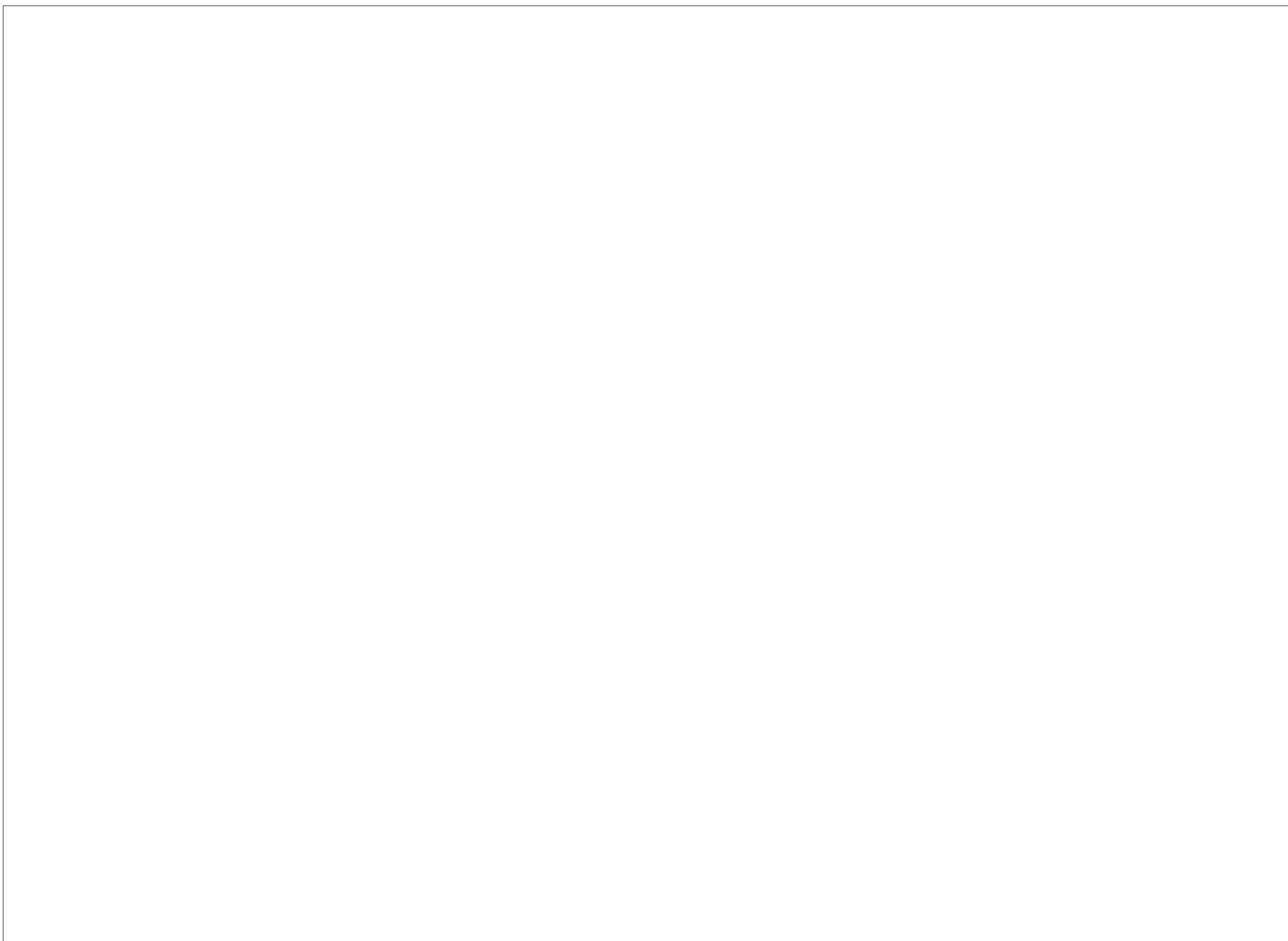

Subject: President and Parliamentary Commission Reach Tentative CEP Agreement

1. (SBU) Summary. President Martelly and representatives from Parliament's bicameral commission on November 30 agreed on a framework to form a Transitional College of the Permanent Electoral Council ("College Transitoire du Conseil Electoral Permanent", CT/CEP) which will organize partial senate and local elections. The understanding-in-principle establishes the framework for a formal agreement that will set in motion the organization of elections. The parties further demonstrated their determination to keep matters on track on December 2, when they held talks focused on resolving a key element: replacing the Superior Judicial Council's (CSPJ) three original – and controversial – CEP representatives (Ref. A) with three others a unanimous CSPJ subsequently selected (Ref. B). End Summary.
