I called Essam Haddad, and I conveyed the message about the date, with the additional message that Bill Burns asked me to convey.

Haddad said they are recalling their ambassador from Tel Aviv for consultations and they have asked their Permrep in New York to call for a special meeting of the UN Security Council. He sounded [REDACTED] about the loss of life in B1 Gaza. Haddad said that he had tried to call me about three hours ago to discuss the steps they were planning to take 1.4(D) but had been unable to reach me. He reiterated several times that the [REDACTED] and that targeted killings were "not acceptable." He said demonstrations were anticipated in Cairo tomorrow calling for a break in relations. (He reiterated that there would be adequate security at our Embassy.) Apparently, the Arab League is 1.4(B) holding a meeting as well. 1.4(D)

[REDACTED] - they are not planning on breaking relations or expelling the Israeli Ambassador in Egypt - and there have been [REDACTED] as well, although he was less sure about the second. He said that Shehata talked to his Israeli counterpart but "with no results." They sent a stiff message to the Israeli ambassador in Egypt. [REDACTED]
