Ken Frazier, the CEO of Merck, has requested a meeting with the Secretary during the window of March 20-22 when he will be in Washington, DC. Merck is the leading private sector partner for Saving Mothers dedicating over \$50m over 5 years and serving as the Secretariat for the partnership. Mr. Frazier has announced at the UN in September that reducing maternal death by 75% over the next ten years is Merck's major corporate social responsibility goal to which they have dedicated a total of \$500m.

His visit would provide a window for the Saving Mothers event with the Secretary at State, per my prior email, if the dates with our ambassadors surrounding the CoM conference do not work.
