Huma and Ted: To close the circle on this issue, I spoke to President Ellen Johnson Sirleaf and the Liberian Perm Rep yesterday afternoon (9/26). President Sirleaf wanted to alert us that an American citizen had been engaged in suspicious activities and would not be allowed to leave Liberia until a police investigation is completed. President Sirleaf asked that we not interfere in the Liberian legal process. I told assured President Sirleaf I would contact our embassy (which I did) and that we would not do anything that undermined Liberia's investigation/legal system. The embassy believes that the liberians are handling this case appropriately and we have informed the Liberians we do not intend to interfere will their proceedings. Johnnie
